Sir,

This has reference to your application vide letter No. PL/PVPL/JSP dated 06.07.2015 submitted under the provisions of Regulation 21 of the PNGRB (Authorizing Entities to Lay, Build, Operate or Expand Petroleum and Petroleum Products Pipelines) Regulations, 2010 for expansion of Mundra-Delhi petroleum and petroleum products pipeline (MDPL) from existing 5.0 MMTPA to 6.9 MMTPA and subsequent communications in this regard.

- 2. The Board has approved HPCL's proposal to expand the system capacity of MDPL from the existing 5.0 MMTPA to 6.9 MMTPA by way of (a) Installation of additional pump stations at Bachau and Pindwara; and (b) Laying 280 km extension spur pipeline from MDPL's existing Palanpur station to HPCL's proposed Marketing Terminal near Vadodara.
- 3. Accordingly, following clauses of final terms and conditions letter dated 23.01.2015 issued by PNGRB for MDPL stands amended as under:
 - In Clause 2 a) (ii), total length of the pipeline to be 1334 km including spurline of 280 km from Palanpur to Vadodara.
 - (ii) In Clause 2 a) (iv), additional pumping stations at Bachau and Pindwara to be included.

- (iii) In Clause 2 a) (v), additional Tap-off Points at Vadodara and Awa to be included.
- (iv) In Clause 2 b), the provisional system capacity of Mundra-Delhi petroleum and petroleum products pipeline to be revised as 6.9 MMTPA* with common carrier capacity of 1.38 MMTPA* after the aforementioned expansion.
- 4. All other terms and conditions of the final terms and conditions letter dated 23.01.2015 shall remain same.
