MSP will have to be given legal status: Jairam Ramesh

Congress held a press conference in Gwalior recently, regarding Bharat Jodo Nyay Yatra. Congress national general secretary Jairam Ramesh told reporters that Bharat Jodo Nyay Yatra is an ideological journey and in the last 50 days, Rahul has been repeatedly talking about five justices; this includes youth, farmers, women and workers. Among these, Rahul Gandhi has given two such guarantees on behalf of the INDIA Alliance. The first step towards justice would be to give MSP a legal status. For that, a special law will be brought in Rajya Sabha and Lok Sabha. The minimum support price will be decided on the basis of the formula given by Dr. Swaminathan. Prime Minister Modi has given Bharat Ratna to Swaminath. It has been given to Chaudhary Charan Singh but he is not implementing the support price formula given by them. MSP



should be one and a half times the cost of farming. That is why Rahul Gandhi has made this promise to the farmers.

Jairam Ramesh said that the second guarantee that Rahul Gandhi has given is the counting of castes in our country. Social, economic and caste census should have been done but it has not been done yet. That census was to be held in 2021 but it has not been done yet. It has been more than 3 years but the census which is conducted every 10 years has not been conducted under the Modi government. Socio-economic and caste census was conducted in 2011 during the government of Dr. Manmohan Singh. Its results revealed that information of 25 crore families was obtained. It has not been published yet. This is not being done by the Modi government, that is why Rahul Gandhi has given a guarantee regarding two out of five justices.

Ultimatum to 24 former ministers to vacate bungalows, Home Department gives notice

Four MLAs also did not vacate the bungalow

'If you do not vacate the bungalow on time, we will take action'

Taking a tough stance on former ministers not vacating their bungalows, the Home Department has issued notices to 24 former ministers, including 4 former MLAs, to vacate their bungalows. Besides, a warning of strict action like eviction has also been given if the bungalow is not vacated within the stipulated time.

Those who did not vacate the bungalow include the names of 28 leaders including Kamal Patel, Meena Singh, Deepak Joshi, Usha



Thakur, Imarti Devi, Ram-pal Singh, Mahendra Singh Sisodia. According to the information, eviction notices have been pasted by the administration to 24 former ministers and 4 former MLAs i.e. 28 leaders.

State government officials said that if the bungalow is not vacated, then another final notice will be given and a final ultimatum of 10 days will be given. After this, the bun-

galow will be vacated by taking action as per rules. It has been said that former Assembly Speaker Girish Gautam along with former ministers OP Sakhalecha, Rajvardhan Singh, Prem Singh Patel and Sanjeev Singh and Bisahulal Singh have vacated the bungalows.

Notices pasted on bungalows

The concerned for-

mer minister and MLA are making unauthorized use of the public premises. In such a situation, as per the rules, there is a provision to evict them from the public premises, therefore, by using the powers obtained in sub-section (1) of section 4 of the Public Premises (Eviction) Act 1974 (No. 46 of 1974), they should give

reason of not vacating the bungalow. The proposed eviction order should not be considered implemented as final. In the notice given to all of them in the first phase, they were asked to vacate the bungalow by February 29, the period for which has expired. These notices have now been pasted on the bungalows.

Self-help groups and youth of the area will be provided training for this by artists from Mathura and Jaipur etc. and stalls will also be arranged in temples for the sale of these materials. The upcoming Regional Industry conclaves will be held in Jabalpur, Rewa and Gwalior. Rs 5,180 cr for irrigation projects: The Council of Ministers approved more than Rs 5,180

crore for the implementation of various irrigation projects in the state. Out of this, Rs 5,42 crore were revised and administrative approval was given for more than Rs 137 crore. Besides, project worth Rs 5,812 crore was approved for upgradation of state highways.

CITIIS 2.0: Under CITIIS 2.0 implemented by the Government of India, the Council of Ministers gave initial approval to the Smart City of Madhya Pradesh to participate in the selection process and implement the plan. CITIIS 2.0 was launched by the Government of India on 16 November 2023. The objective of the scheme is to promote climate sensitive planning and implementation and to motivate investment, creation of institutional mechanism, participation promotion and capacity building for urban climate implementation. Under the scheme, 18 smart cities are to be selected through challenge among 100 smart cities. Under this, seven smart cities of the state have been initially included in the selection process.
